COLUMBIA, S.C. – December 23, 2009 – The South Carolina Department of Commerce, Lexington County and the Central SC Alliance today announced that Husqvarna will locate a parts distribution operation in Lexington County. The company anticipates investing more than \$2.5 million and will be the principal tenant in a newly constructed building.
